## **SURFACE PREPARATION**

**New or Bare Wood (Interior):** Sand to remove mill glaze to expose fresh wood cells prior to applying paint or stain. Remove sanding dust prior to application of stain.

## **Application Equipment**

Brush: Use a good quality pure bristle brush.

Roller: Use a 1/4"--a longer nap synthetic cover may be needed depending on the degree of texture of the surface to be painted.
