For surfaces with peeling coatings or heavy stains, apply an alkaline/caustic wood stripper to remove the coating. Once dry use SHARKSKIN Wood Cleaner & Brightener to restore wood to original color.

DIRECTIONS FOR USE:

- Dilute SHARKSKIN Wood Cleaner & Brightener with water at 1:4 parts for normal cleaning.
- A dilution of 1:1 may be needed for deep stains.
- Apply with pump up sprayer, leave on surface for 10 minutes.
- Use a stiff bristle brush to remove residue from surface.
- Rinse using a garden hose or pressure washer at a low pressure setting.
