SHARKSKIN Deck & Siding Stripper is a highly concentrated, alkaline formulation manufactured to quickly remove old and worn stains, solid color, oil based stains, latex paint, and sealers from wood surfaces prior to the application of new finishes.

SHARKSKIN Deck Stripper will also degrease and clean while removing damaged and discolored wood fiber from all exterior wood surfaces, decks, wood siding and log homes.

DIRECTIONS FOR USE:

- Dilute SHARKSKIN Deck Stripper with water at a 1:1 or 1:2 ratio subject to conditions, to remove most stains and sealers from wood.
- Apply with a pump up sprayer and wait 15-30 minutes, or until coating softens or dissolves.
- Use a stiff bristle brush to remove residue from surface.
- Rinse using a garden hose or pressure washer at a low pressure setting.
- For solid finishes product may need to be used without dilution.

WARNINGS:

- Do not allow product to dry on surface
- Protect metal and glass from contact
- Thoroughly wet surrounding vegetation
- Contains sodium hydroxide, potassium hydroxide and other alkaline materials
- Always test in an inconspicuous area first
